Summary

The Colchester Archaeological Trust undertook a watching brief during the construction of an extension to the side and rear of 32 Thompson Avenue, Colchester, Essex.

No archaeological features were recorded during the scope of the watching brief.

Introduction

This is the archive report on the archaeological watching brief carried out by the Colchester Archaeological Trust (CAT) on behalf of Mr and Mrs Dubber at 32 Thompson Avenue, Colchester, Essex (NGR TL 596912 224731) (Fig 1). The site is located to the west of the historic walled town, to the south of the Roman road to London, within a residential area.

The archaeological monitoring was undertaken during the excavation of foundation trenches for a single-storey extension to the rear and side of the existing property (application No.146211). The aim of the watching brief was to identify and record any surviving archaeological deposits affected by the groundworks.

Thompson Avenue is situated in an area of Colchester considered to have high archaeological potential, namely the western cemetery of the Iron Age oppidum of Camulodunum (EHER 11714). The site is approximately 160m south-west of 'The Mount' (EHER 11707) an Iron Age mound thought to be the burial place of a Belgic chieftain, as the tumulus nearby (Lexden Tumulus, EHER 11711) proved to be. These tumuli suggest that that this area is one of the main burial sites for pre-Roman Colchester. Additional archaeological sites in the vicinity include the find spot of a Bronze Age bucket urn found in Shakespeare Road (EHER 11611) 200m to the west and an undated rectangular enclosure (EHER 11917 known from crop marks but subsequently built over by the estate) 150m to the north-east.

All fieldwork and reporting was done in accordance with CAT's Policies and procedures (CAT 2008), Colchester Borough Council's Guidelines on standards and practices for archaeological fieldwork in the Borough of Colchester (CIMS 2008a), Guidelines on the preparation and transfer of archaeological archives to Colchester and Ipswich Museums (CIMS 2008b), and the Chartered Institute for Archaeologists' Standard and guidance for an archaeological watching brief (ClfA 2008a) and Standard and guidance for the collection, documentation, conservation and research of archaeological materials (ClfA 2008b). The guidance contained in English Heritage's Management of Research Projects in the Historic Environment (MoRPHE 2006) and in the documents Research and archaeology: a framework for the Eastern Counties 1. Resource assessment (EAA 3), Research and archaeology: a framework for the Eastern Counties 2. Research agenda and strategy (EAA 8), Standards for field archaeology in the East of England (EAA 14) and Research and Archaeology Revised: A Revised Framework for the East of England (EAA 24) was also followed.

Results

The archaeological monitoring took place on the morning of 9th February 2015 and consisted of one site visit. The excavation of the foundation trenches was carried out under continuous archaeological supervision using a mechanical excavator equipped with a 500mm wide toothless bucket.






Fig 2 Representative section.

A modern topsoil (L1) overlay a medium brown loam (L2) which, in turn, overlay the natural sand and gravel (L3) (Fig 2). L1 contained modern slate and brick fragments (not retained). No finds or inclusions were observed in L2. In the west side of the foundation trenches natural sand and gravel (L3) was found to be approximately 100mm below ground level falling to 600mm below ground level at the eastern end of the foundation trench. This appears to have been the result of terracing when the estate was built in the early 1960s and suggests significant disturbance to any archaeological remains in the surrounding area.

No archaeological remains were recorded during the watching brief.
